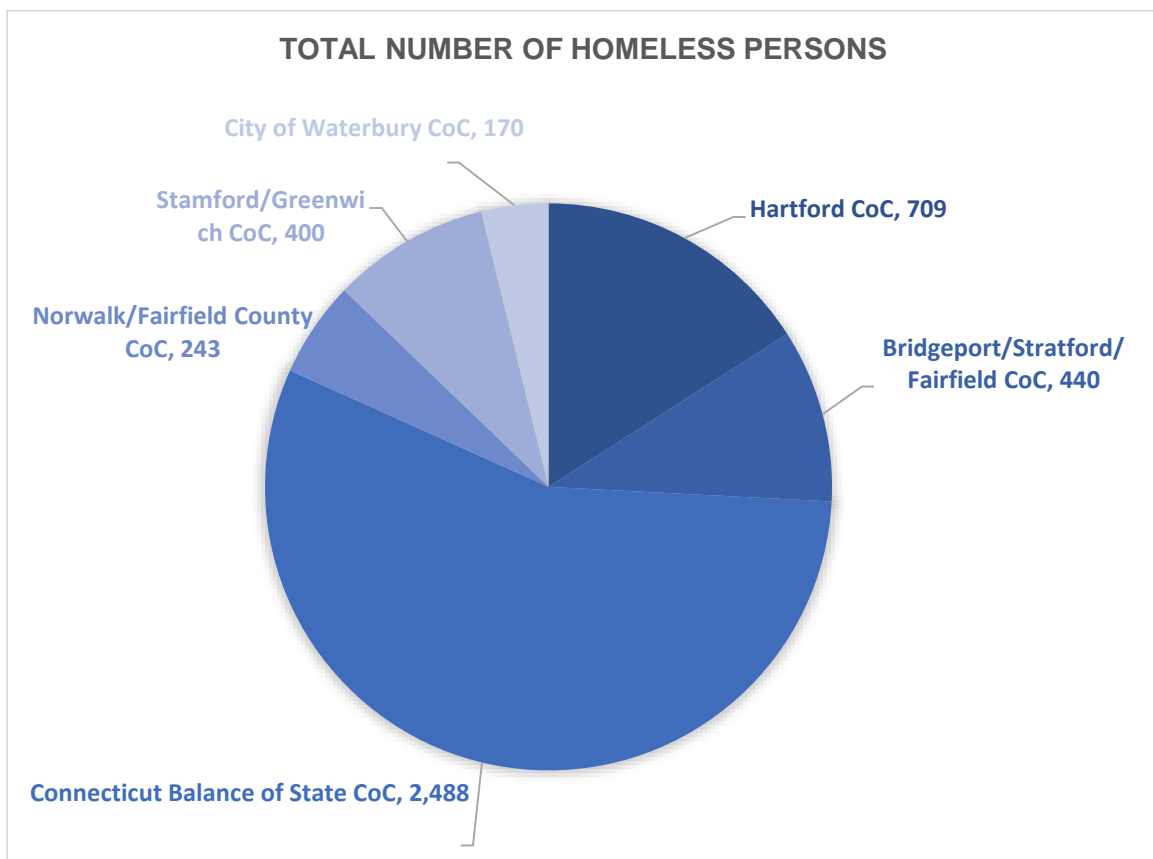


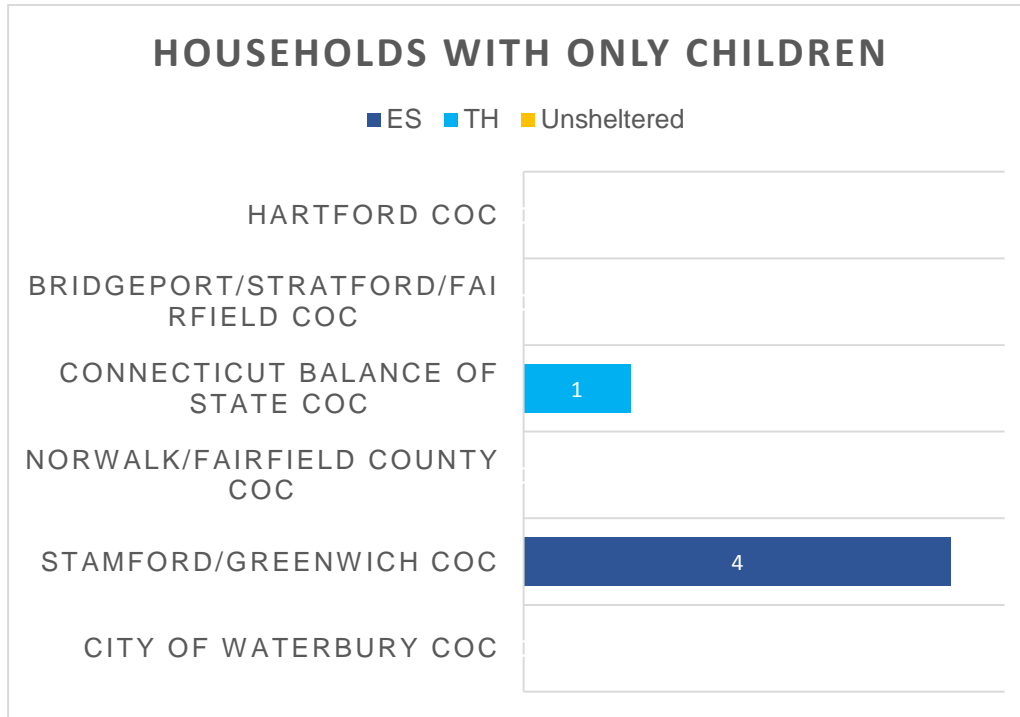
CONNECTICUT

In Connecticut, there were 4,450 homeless persons on a given night in January 2014. As the figure shows, 709 of them were in the Hartford CoC, 440 were in the Bridgeport/Stratford/Fairfield CoC, 400 were in the Stamford/Greenwich CoC, 243 were in the Norwalk/Fairfield County CoC, 170 were in the City of Waterbury CoC, and 2,488 were in the Connecticut Balance of State CoC. There were 5 children alone, 1,381 persons in households with children, 189 young adults ages 18 to 24 alone, and 2,875 adults ages 24 and older alone. One-fifth of the homeless persons in Connecticut were without shelter.



Children Alone

Of the 5 children alone, 4 were in the Stamford/Greenwich CoC and 1 was in the Connecticut Balance of State CoC. The four children in the Stamford/Greenwich CoC were in emergency shelters and the child in the Connecticut Balance of State CoC was in transitional housing.

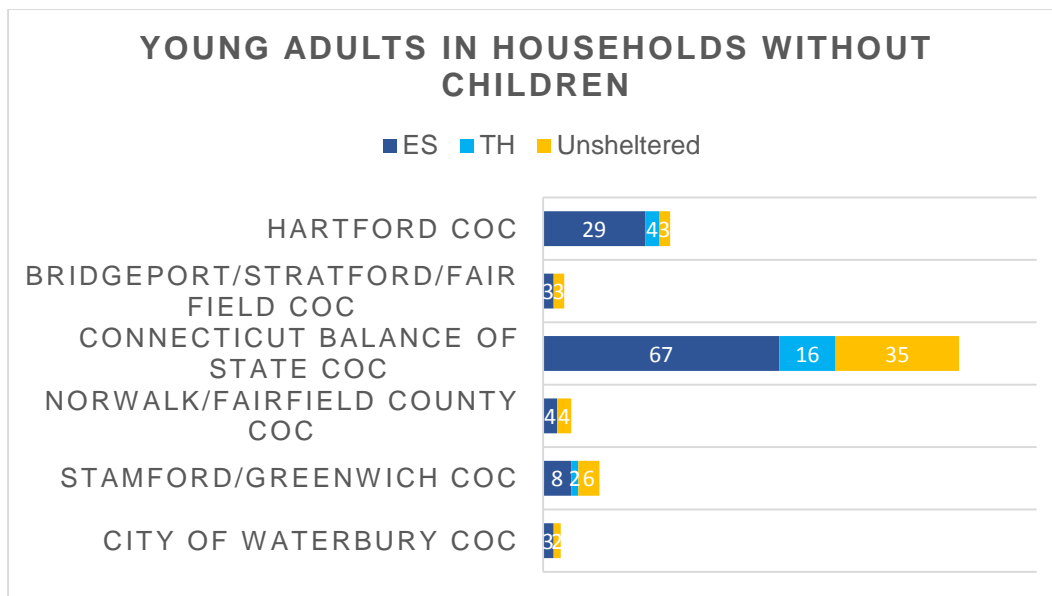


None of the children living alone in Connecticut were without shelter. The Housing Inventory Count reports 14 to 44 youth beds available for children alone. Therefore, there were enough beds for children living alone.

Young Adults Alone

Of the 189 young adults living alone in Connecticut, 114 were in emergency shelters, 22 were in transitional housing, and 53 were without shelter. Sixty-two percent of the young adults were living in the Connecticut Balance of State CoC, 19 percent were living in the Hartford CoC, 8 percent were living in the Stamford/Greenwich CoC, and the other 10 percent were living in the Bridgeport/Stratford/Fairfield CoC, Norwalk/Fairfield County CoC, and the City of Waterbury CoC.



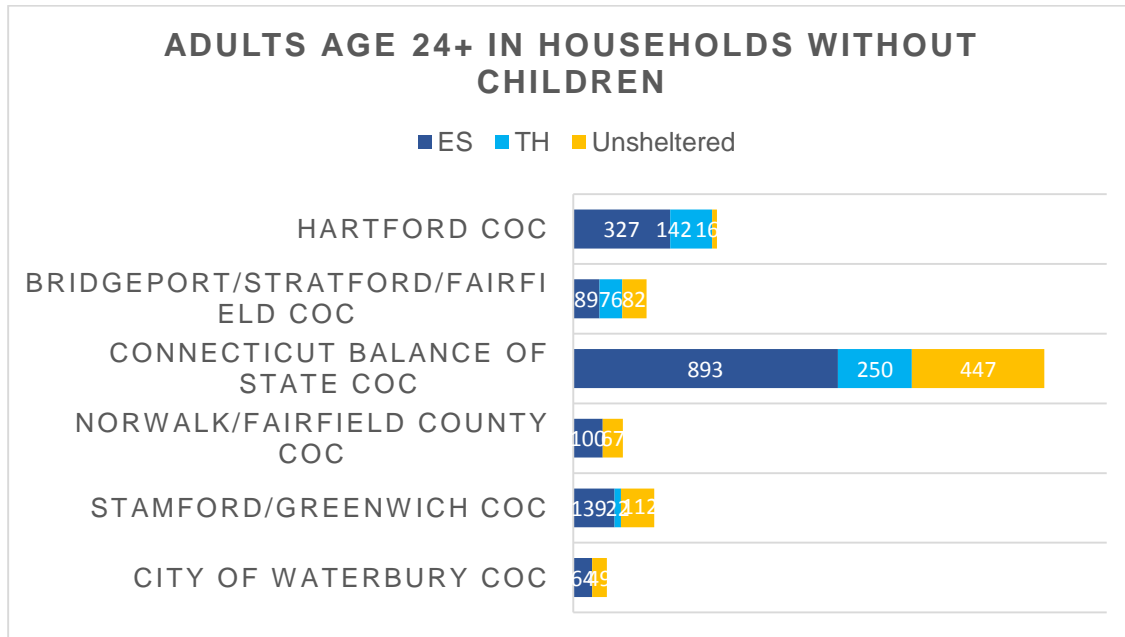
Twenty-eight percent of the young adults were without shelter. Sixty-six percent of the 53 young adults without shelter were in the Connecticut Balance of State CoC, 11 percent were in the Stamford/Greenwich CoC, 7 percent were in the Norwalk/Fairfield County CoC, and the other 15 percent were in the Hartford CoC, Bridgeport/Stratford/Fairfield CoC, and the City of Waterbury CoC.

Although 53 young adults were without shelter in Connecticut, the Housing Inventory Count reports only 6 to 36 youth beds were available for young adults alone. When evaluating the number of beds needed in each CoC, a total of 18 to 47 additional youth beds are needed for young adults in Connecticut.

Adults Alone

Of the 2,875 adults age 24 and older living in households without children in Connecticut, 1,612 were in emergency shelters, 490 were in transitional housing, and 773 were without shelter. Fifty-five percent of the adults age 24 and older were located in the Connecticut Balance of State CoC, 16 percent were in the Hartford CoC, 9 percent were in the Stamford/Greenwich CoC, 8 percent were in the Bridgeport/Stratford/Fairfield CoC, 5 percent were in the Norwalk/Fairfield County CoC, and 3 percent were in the City of Waterbury CoC.



Twenty-six percent of the adult individuals were without shelter. Fifty-seven percent of the adult individuals without shelter (447 individuals) were in the Connecticut Balance of State CoC, 14 percent (112 individuals) were in the Stamford/Greenwich CoC, 10 percent (82 individuals) were in the Bridgeport/Stratford/Fairfield CoC, 8 percent (67 individuals) were in the Norwalk/Fairfield County CoC, 6 percent (49 individuals) were in the City of Waterbury CoC, and 2 percent (16 individuals) were in the Hartford CoC.

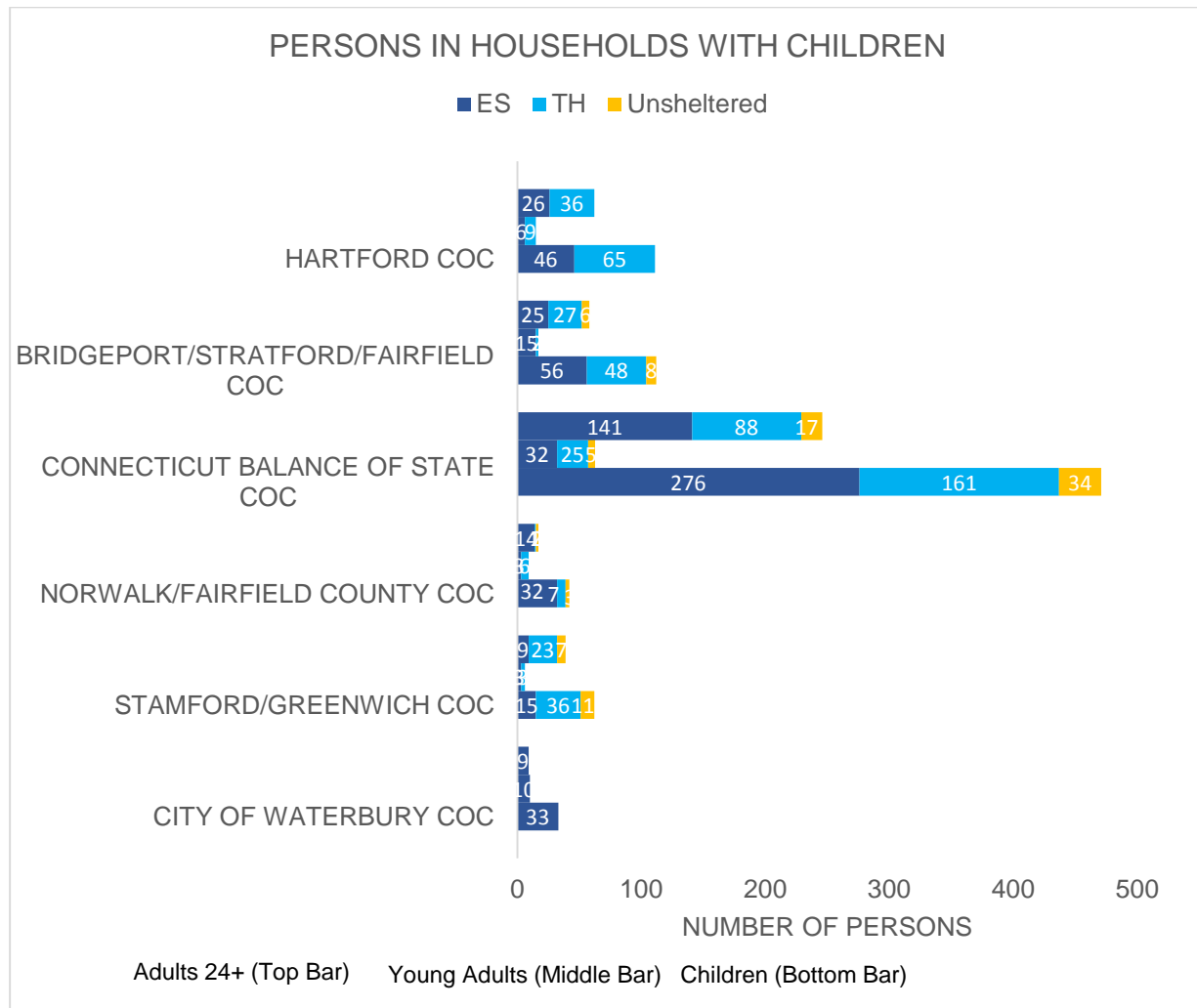

Although 773 adult individuals were without shelter in Connecticut, the Housing Inventory Count reports only 264 to 520 beds were available for adult individuals age 24 and older. When evaluating the number of beds needed in each CoC, a total of 266 to 516 additional beds are needed for adult individuals without shelter. Between 27 and 254 additional beds are needed in the Connecticut Balance of State CoC, 46 and 55 additional beds are needed in the Hartford CoC, 54 and 64 additional beds are needed in the Norwalk/Fairfield County CoC, 33 and 37 additional beds are needed in the City of Waterbury CoC, and 106 additional beds are needed in the Stamford/Greenwich CoC.

Families With Children

Of the 1,381 homeless adults and children living together in families in Connecticut, 751 were in emergency shelters, 537 were in transitional housing, and 93 were without shelter. Fifty-six percent of the persons in households with children were living in the Connecticut Balance of State CoC, 13 percent were living in the Hartford CoC, 13 percent were living in the Bridgeport/Stratford/Fairfield CoC, 7 percent were living in the Stamford/Greenwich CoC, 4 percent were living in the Norwalk/Fairfield County CoC, and 3 percent were living in the City of Waterbury CoC.



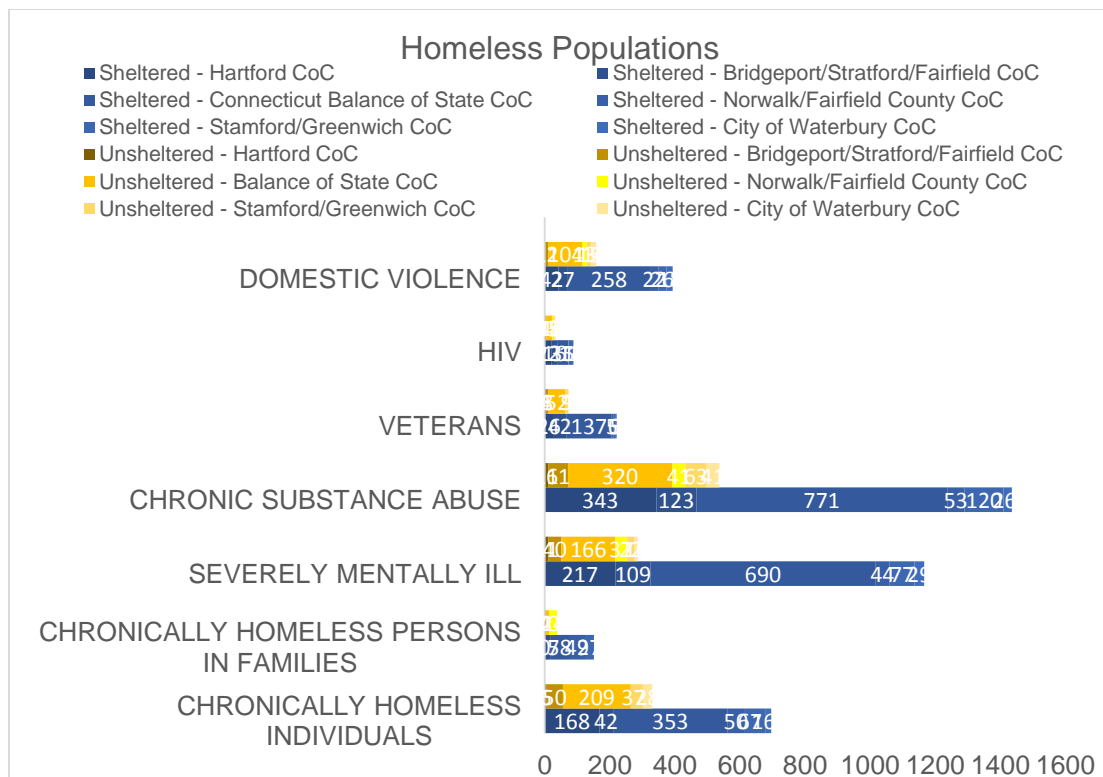
Although 93 adult and children were living together in families without shelter in Connecticut, the Housing Inventory Count reports 110 to 360 beds were available and not all of these beds may have been in available units. When evaluating the number of beds needed in each CoC, a total of 16 to 53 additional beds are needed for households with children without shelter.

Homeless Populations

In Connecticut, 27 percent of the 4,450 persons homeless on a given night in January 2014 were chronically homeless. Also, 32 percent were characterized as severely mentally ill and 44 percent were characterized as having chronic substance abuse. Veterans comprised 6 percent of the homeless population, domestic violence survivors comprised 12 percent of the homeless population, and persons with HIV/AIDS comprised 2 percent of the homeless population.



Chronically Homeless Persons

Of the 4,450 homeless people in Connecticut, 1,215 were chronically homeless. Thirty percent of the chronically homeless persons were without shelter: 330 individuals and 38 persons in families.

Sixty-three percent of the chronically homeless individuals without shelter were in the Connecticut Balance of State CoC, 15 percent were in the Bridgeport/Stratford/Fairfield CoC, 11 percent were in the Stamford/Greenwich CoC, 8 percent were in the City of Waterbury CoC, and 1 percent were in the Hartford CoC. The Housing Inventory Count reports between 230 and 375 rapid rehousing, transitional housing, permanent housing, and safe haven beds were available for households without children. When evaluating the number of beds needed in each CoC, between 67 and 116 more transitional housing, permanent housing, and rapid-rehousing beds may be needed for chronically homeless individuals.

Sixty-three percent of the chronically homeless persons in families without shelter were in the Norwalk/Fairfield County CoC, 26 percent were in the Connecticut Balance of State CoC, and 10 percent were in the Bridgeport/Stratford/Fairfield CoC. The Housing Inventory Count reports between 63 and 206 rapid rehousing, transitional housing, permanent housing, and safe haven beds were available for households with children. When evaluating the number of beds needed in each CoC, between 22 and 24 more transitional housing, permanent housing, and rapid-rehousing beds may be needed for chronically homeless persons in families.

Domestic Violence Survivors

Of the 4,450 homeless people in Connecticut, 551 were escaping domestic violence. Twenty-eight percent of the domestic violence survivors (158 individuals) were without shelter.

Sixty-five percent of the domestic violence survivors without shelter were in the Connecticut Balance of State CoC, 9 percent were in the Stamford/Greenwich CoC, 8 percent were in the Norwalk/Fairfield County CoC and City of Waterbury CoC, and 7 percent were in the Bridgeport/Stratford/Fairfield CoC. The Housing Inventory Count reports between 3 and 49 domestic violence and rapid rehousing beds for households without children and between 11 and 57 domestic violence and rapid rehousing beds for households with children. Depending on the number of beds in available units, between 60 and 146 more beds may be needed for adults and children escaping domestic violence. More than 60 or 146 beds may also be needed if there are more individuals than beds available for individuals or more persons in households with children than beds available for households with children.

Conclusion

In Connecticut, there were 4,450 homeless persons and 919 persons without shelter. There may be enough beds for children living alone, but at least 18 to 47 additional beds are needed for young adults alone without shelter, 266 to 516 additional beds are needed for adult individuals without shelter, and 16 to 53 additional beds are needed for households with children without shelter. At least 67 to 116 additional beds are needed for chronically homeless individuals, 63 to 206 additional beds are needed for chronically homeless persons in families, and 60 to 146 additional domestic violence beds are needed. Additional shelters or beds are needed in all six Connecticut CoCs.
