

GEORGIA

In Georgia, there were 16,521 homeless persons on a given night in January 2014. As the figure shows, 7,577 of them were in the Georgia Balance of State CoC, 4,797 were in the Atlanta CoC, 1,315 were in the Savannah/Chatham County CoC, 801 were in the DeKalb County CoC, 523 were in the Marietta/Cobb County CoC, 477 were in the Fulton County CoC, 472 were in the Augusta CoC, 312 were in the Columbus-Muscogee/Russell County CoC, and 247 were in the Athens/Clarke County CoC. There were 94 children alone, 4,118 persons in households with children, 935 young adults ages 18 to 24 alone, and 11,374 adults ages 24 and older alone. Half of the homeless persons in Georgia were without shelter.



Children Alone

Of the 94 children alone, 10 were in emergency shelters and 84 were without shelter. Sixty-four percent of the children alone were in the Georgia Balance of State CoC, 18 percent were in the Atlanta CoC, 7 percent were in the Savannah/Chatham County CoC and the DeKalb County CoC, and 2 percent were in the Augusta CoC.




Eighty-nine percent of the children living alone in Georgia were without shelter. Seventy-one percent of the children living alone without shelter were the Georgia Balance of State CoC, 20 percent were in the Atlanta CoC, and 8 percent were in the DeKalb County CoC. The Housing Inventory Count reports 14 - 41 youth beds available for children alone. When evaluating the number of beds needed in each CoC, a total of 55 to 75 additional beds are needed for children living alone without shelter in Georgia. Zero to eight additional beds are needed in the Atlanta CoC, between 55 and 60 additional youth beds are needed in the Georgia Balance of State COC, and 0 to 7 additional youth beds are needed in the DeKalb County CoC.

Young Adults Alone

Of the 935 young adults living alone in Georgia, 278 were in emergency shelters, 141 were in transitional housing, and 516 were without shelter. Thirty-nine percent of the young adults were living in the Georgia Balance of State CoC, 31 percent were living in the Atlanta CoC, 11 percent were living in Savannah/Chatham County CoC, 6 percent were living in the DeKalb County CoC, 3 percent were in the Columbus-Muscogee/Russell County CoC, 2 percent were in the Athens/Clarke County CoC and August CoC, and 1 percent were in the Fulton County CoC and Marietta/Cobb County CoC each.



Fifty-five percent of the young adults were without shelter. Sixty percent of the young adults without shelter were in the Georgia Balance of State CoC, 11 percent were in the Atlanta CoC, 17 percent were in the Savannah/Chatham County CoC, 2 percent were in DeKalb County CoC, Fulton County CoC, and Columbus-Muscogee/Russel County CoC, and 1 percent were in Athens/Clarke County CoC, Augusta CoC, and Marietta/Cobb County CoC each.



Although 516 young adults were without shelter in Georgia, the Housing Inventory Count reports only 26 to 46 youth beds were available for young adults alone. When evaluating the number of beds needed in each CoC, a total of 470 to 490 additional beds are needed for young adults alone without shelter in Georgia.

Adults Alone

Of the 11,374 adults age 24 and older living in households without children in Georgia, 2,716 were in emergency shelters, 1,787 were in transitional housing, and 6,871 were without shelter. Forty-two percent of the adults age 24 and older were located in the Georgia Balance of State CoC, 34 percent were in the Atlanta CoC, 9 percent were in the Savannah/Chatham County CoC, 3 percent were in the DeKalb County CoC, 2 percent were in the Augusta CoC and Marietta/Cobb County CoC, and 1 percent were in each of the following three counties Fulton County CoC, Athens/Clarke County CoC, and Columbus-Muscogee/Russell County CoC.



Sixty percent of the adult individuals were without shelter. Sixty-one percent of the adult individuals without shelter were in the Georgia Balance of State CoC, 18 percent were in the Atlanta CoC, 9 percent were in the Savannah/Chatham County CoC, 3 percent were in the DeKalb County CoC, and the remainder were in the Fulton County CoC, Athens/Clarke County CoC, Augusta CoC, Columbus-Muscogee/Russell County CoC, and Marietta/Cobb County CoC.


Although 6,871 adult individuals were without shelter in Georgia, the Housing Inventory Count reports only 905 to 1,533 beds were available for adult individuals age 24 and older. When evaluating the number of beds needed in each CoC, a total of 5,388 to 5,966 additional beds are needed for adult individuals without shelter. Additional beds are needed in all 9 of the Georgia CoCs with 67 percent of the additional beds needed in the Georgia Balance of State CoC, 13 percent needed in the Atlanta CoC, and 9 percent needed in the Savannah/Chatham County CoC.

Families With Children

Of the 4,118 homeless adults and children living together in families in Florida, 1,437 were in emergency shelters, 1,845 were in transitional housing, and 836 were without shelter. Fifty-six percent of the persons in households with children were living in the Georgia Balance of State CoC, 14 percent were living in the Atlanta CoC, 8 percent were living in the DeKalb County CoC, 5 percent were living in the Fulton County CoC and Marietta/Cobb County CoC each, 3 percent were living in the Savannah/Chatham County CoC, 2 percent were living in the Augusta CoC, and 1 percent were living in the Athens/Clarke County CoC and Columbus/Muscogee/Russell County CoC each.




Although 836 adult and children were living together in families without shelter in Georgia, the Housing Inventory Count reports 648 to 1,302 beds were available and not all of these beds may have been in available units. When evaluating the number of beds needed in each CoC, at least 90 to 508 additional beds are needed for adults and children in families in Georgia. Additional beds may be needed for adults and children in families in 6 of the 9 Georgia CoCs.

Homeless Populations

In Georgia, 18 percent of the 16,521 persons homeless on a given night in January 2014 were chronically homeless. Also, 12 percent were characterized as severely mentally ill and 25 percent were characterized as having chronic substance abuse. Veterans comprised 8 percent of the homeless population, domestic violence survivors comprised 9 percent of the homeless population, and persons with HIV/AIDS comprised 2 percent of the homeless population.



Chronically Homeless Persons

Of the 16,521 homeless people in Georgia, 3,004 were chronically homeless. Sixty-eight percent of the chronically homeless persons were without shelter: 1,783 individuals and 276 persons in families.

Forty percent of the chronically homeless individuals without shelter were in the Georgia Balance of State CoC, 39 percent were in the Atlanta CoC, 5 percent were in the Savannah/Chatham County CoC, 4 percent were in the DeKalb County CoC, 2 percent were in the Fulton County CoC, Augusta CoC, Columbus-Muscogee/Russell County CoC, and Marietta/Cobb County CoC each, and 1 percent were in the Athens/Clarke County CoC. The Housing Inventory Count reports between 601 and 954 rapid rehousing, transitional housing, permanent housing, and safe haven beds were available for households without children. When evaluating the number of beds needed in each CoC, between 853 and 1,182 more transitional housing, permanent housing, and rapid-rehousing beds may be needed for chronically homeless individuals.

Ninety percent of the chronically homeless persons in families without shelter were in the Georgia Balance of State CoC, 2 percent were in the Atlanta CoC, Augusta CoC, and Marietta/Cobb County CoC each, and 1 percent were in the Fulton County CoC. The Housing Inventory Count reports between 403 and 763 rapid rehousing, transitional housing, permanent housing, and safe haven beds were available for households with children. When evaluating the number of beds needed in each CoC, between 7 and 89 more transitional housing, permanent housing, and rapid-rehousing beds may be needed for chronically homeless persons in families.

Domestic Violence Survivors

Of the 16,521 homeless people in Georgia, 1,537 were escaping domestic violence. Thirty-five percent of the domestic violence survivors (545 individuals) were without shelter.

Ninety-one percent of the domestic violence survivors without shelter were in the Georgia Balance of State CoC, 3 percent were in the Athens/Clarke County CoC, 2 percent were in the Augusta CoC and the DeKalb County CoC each, and between 0 and 1 percent were in the Savannah/Chatham County CoC. The Housing Inventory Count reports between 23 and 168 domestic violence and rapid rehousing beds for households without children and between 127 and 312 domestic violence and rapid rehousing beds for households with children. Depending on the number of beds in available units, between 158 and 441 more beds may be needed for adults and children escaping domestic violence in Georgia.

Conclusion

In Georgia, there were 16,521 homeless persons and 8,307 persons without shelter. At least 55 to 75 additional beds are needed for children living alone, 470 to 490 additional beds are needed for young adults alone without shelter, 5,388 to 5,966 additional beds are needed for adult individuals without shelter, and at least 90 to 508 additional beds are needed for adults and children in families without shelter. At least 853 and 1,182 additional beds are needed for chronically homeless individuals, 7 and 89 additional beds are needed for chronically homeless persons in families, and 158 and 441 additional domestic violence beds are needed. Additional shelters or beds are needed in all nine Georgia CoCs.
