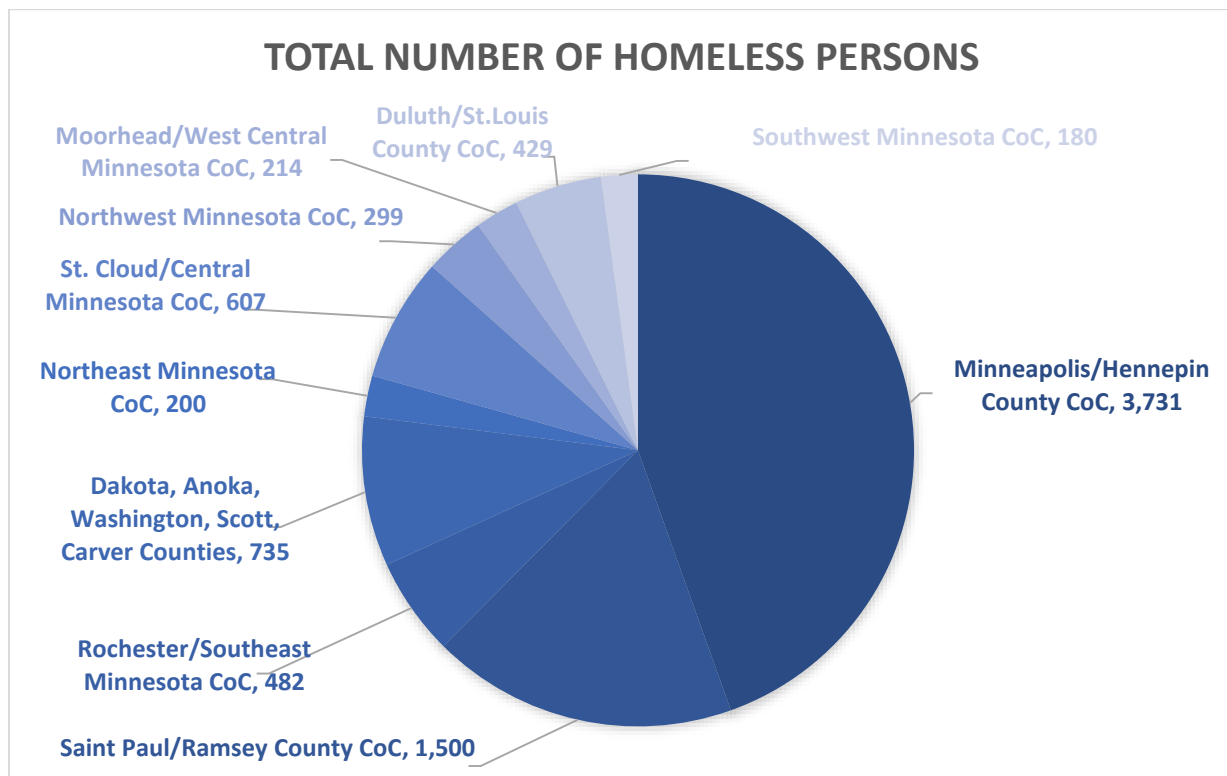


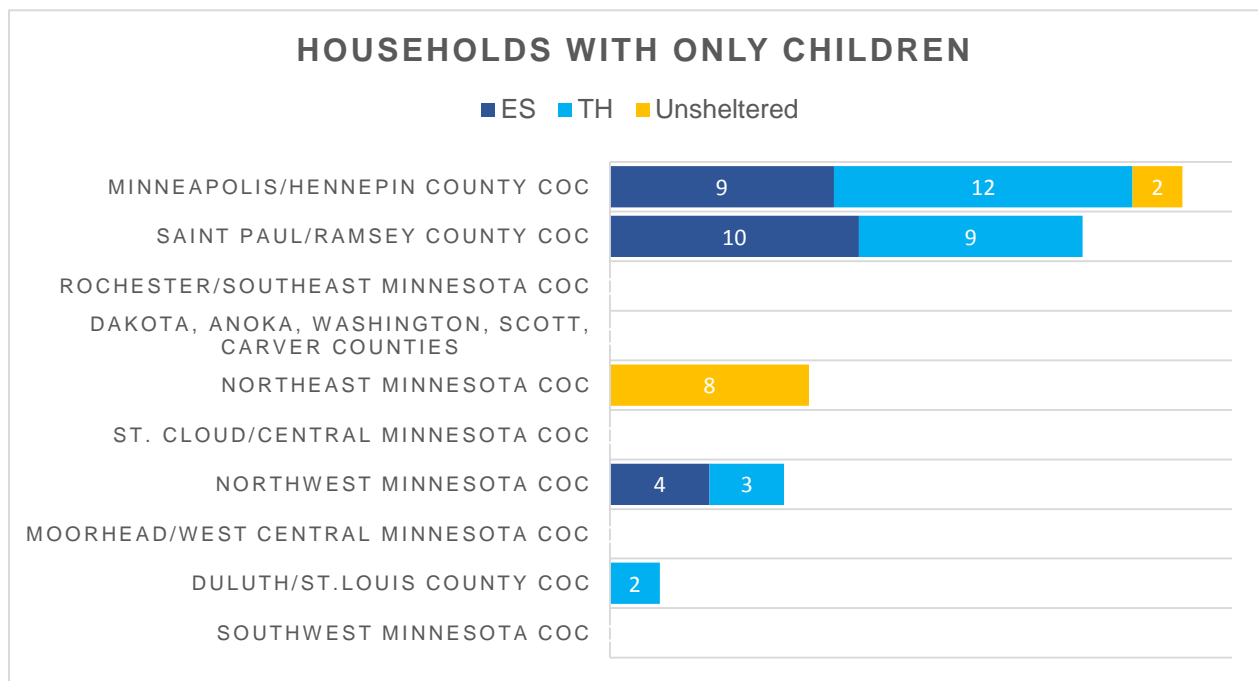
MINNESOTA

In Minnesota, there were 8,377 homeless persons on a given night in January 2014. As the figure shows, 84 percent of the total number were located in five of Minnesota's ten CoCs: 3,731 were in the Minneapolis/Hennepin County CoC, 1,500 were in the Saint Paul/Ramsey County CoC, 735 were in the Dakota, Anoka, Washington, Scott, Carver Counties CoC, 607 were in the St. Cloud/Central Minnesota CoC, and 482 were in the Rochester/Southeast Minnesota CoC. There were 59 children alone, 4,725 persons in households with children, 588 young adults ages 18 to 24 alone, and 3,005 adults ages 24 and older alone. Nine percent of the homeless persons in Minnesota were without shelter.



Children Alone

Of the 59 children alone, 38 percent were in the Minneapolis/Hennepin County CoC. In the Minneapolis/Hennepin County CoC, 9 children were in emergency shelters, 12 children were in transitional housing, and 2 children were without shelter. In the Saint Paul/Ramsey County CoC, 10 children were in emergency shelters and 9 children were in transitional housing. The eight children in the Northeast Minnesota CoC were without shelter. In the Northwest Minnesota CoC, 4 children were in emergency shelters and 3 children were in transitional housing. The 2 children in the Duluth/St. Louis County CoC were in transitional housing.



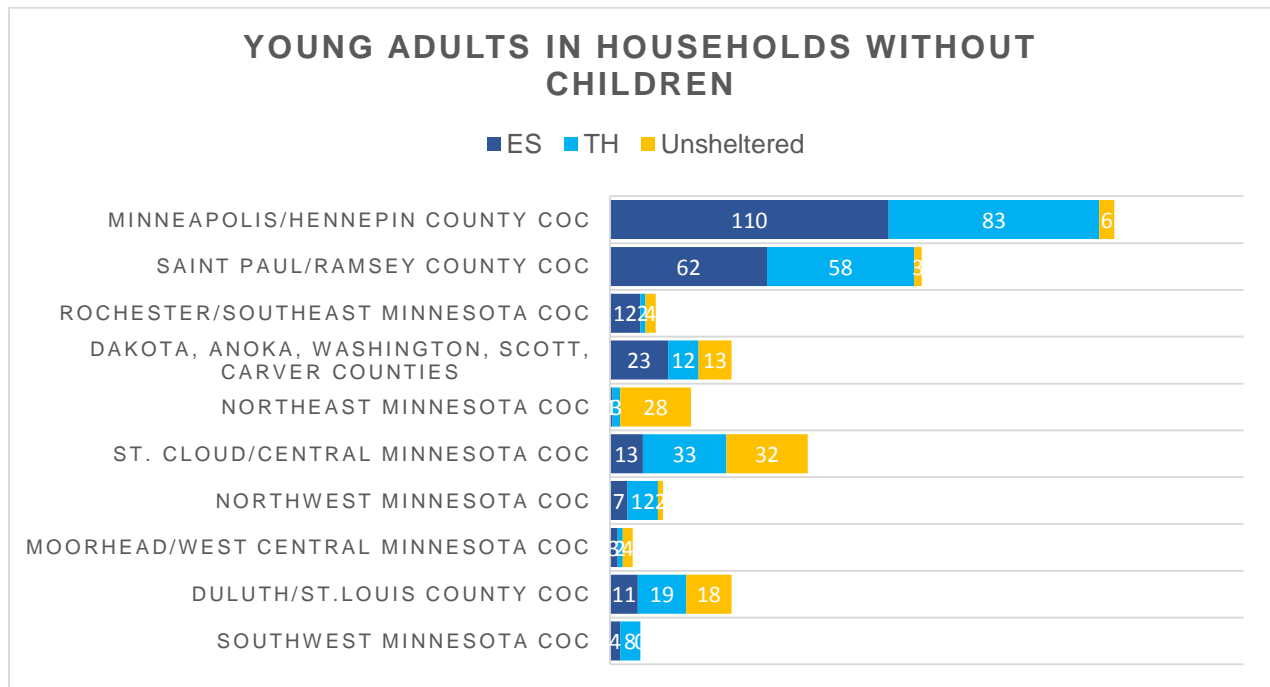
The Housing Inventory Count reports 38 to 91 youth beds available for children alone. When evaluating the number of beds needed in each CoC, a total of 5 additional beds are needed for children living alone.

Young Adults Alone

Of the 588 young adults living alone in Minnesota, 246 were in emergency shelters, 232 were in transitional housing, and 110 were without shelter. Eighty-four percent of the young adults were living in the five continuum of cares Minneapolis/Hennepin County CoC (199 individuals), Saint Paul/Ramsey County CoC (123 individuals), Dakota, Anoka, Washington, Scott, Carver Counties CoC (48 individuals), St. Cloud/Central Minnesota CoC (78 individuals), and Duluth/St. Louis County CoC (48 individuals).



Eighteen percent of the young adults living alone in Minnesota were without shelter. Of the 110 young adults living alone without shelter, 82 percent were located in four CoCs: Dakota, Anoka, Washington, Scott, Carver Counties CoC (13 individuals), Northeast Minnesota CoC (28 individuals), St. Cloud/Central Minnesota CoC (32 individuals), and Duluth/St. Louis County CoC (18 individuals).

Although 110 young adults without shelter were in 9 of Minnesota's 10 CoCs, the Housing Inventory Count reports only 22 to 75 youth beds were available for young adults alone. When evaluating the number of beds needed in each CoC, a total of 77 to 92 additional beds are needed for young adults alone without shelter in Minnesota.

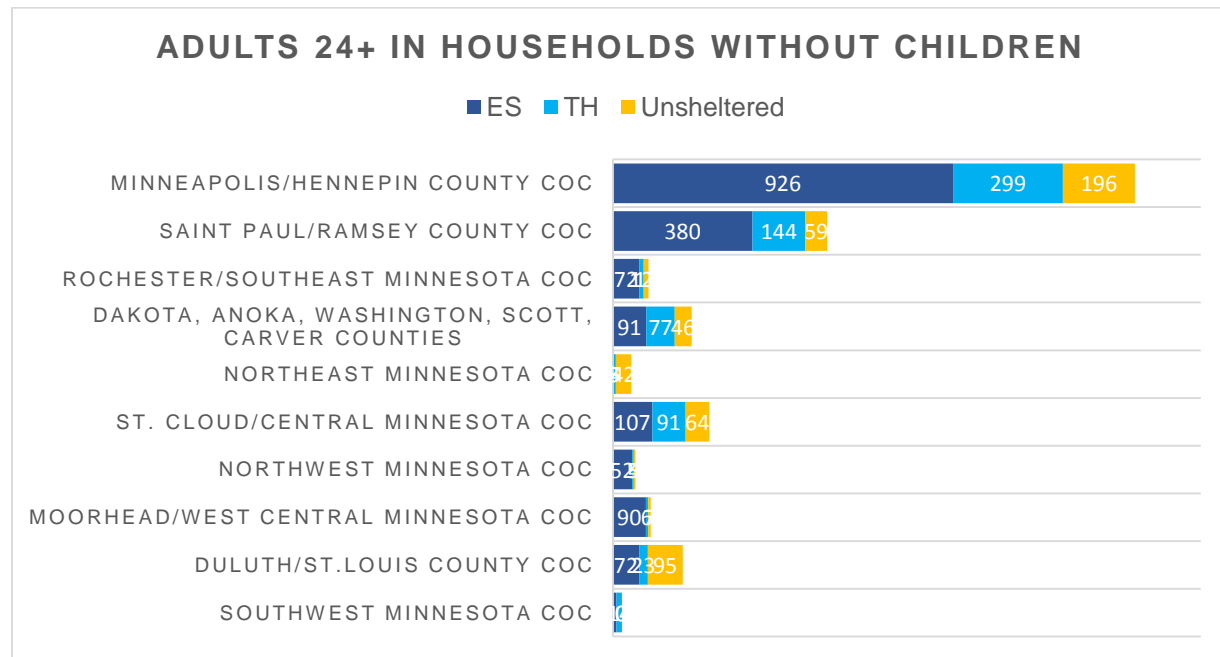
Additional beds are needed in seven continuum of cares: Rochester/Southeast Minnesota CoC (4 more beds needed), Dakota, Anoka, Washington, Scott, Carver Counties CoC (13 more beds needed), Northeast Minnesota CoC (27 more beds needed), St. Cloud/Central Minnesota CoC (14 – 24 more beds needed), Northwest Minnesota CoC (0 – 2 more beds needed),

Moorhead/West Central Minnesota CoC (4 more beds needed), and Duluth/St. Louis County CoC (15 – 18 more beds needed).

Adults Alone

Of the 3,005 adults age 24 and older living in households without children in Minnesota, 1,803 were in emergency shelters, 676 were in transitional housing, and 526 were without shelter. Eighty-eight percent of the adults age 24 and older were located in five CoCs: Minneapolis/Hennepin County CoC (1,421 individuals), Saint Paul/Ramsey County CoC (583 individuals), Dakota, Anoka, Washington, Scott, Carver Counties CoC (214 individuals), St. Cloud/Central Minnesota CoC (262 individuals), and Duluth/St. Louis County CoC (190 individuals).



Seventeen percent of the adult individuals were without shelter. Of the 526 adult individuals living alone without shelter, 87 percent were located in five CoCs: Minneapolis/Hennepin County CoC (196 individuals), Saint Paul/Ramsey County CoC (59 individuals), Dakota, Anoka, Washington, Scott, Carver Counties CoC (46 individuals), St. Cloud/Central Minnesota CoC (64 individuals), and Duluth/St. Louis County CoC (95 individuals).

Although 526 adult individuals 24 and older were without shelter in Minnesota, the Housing Inventory Count reports only 484 to 749 beds were available. When evaluating the number of beds needed in each CoC, a total of 111 to 191 additional beds are needed for adult individuals 24 and older in Minnesota.

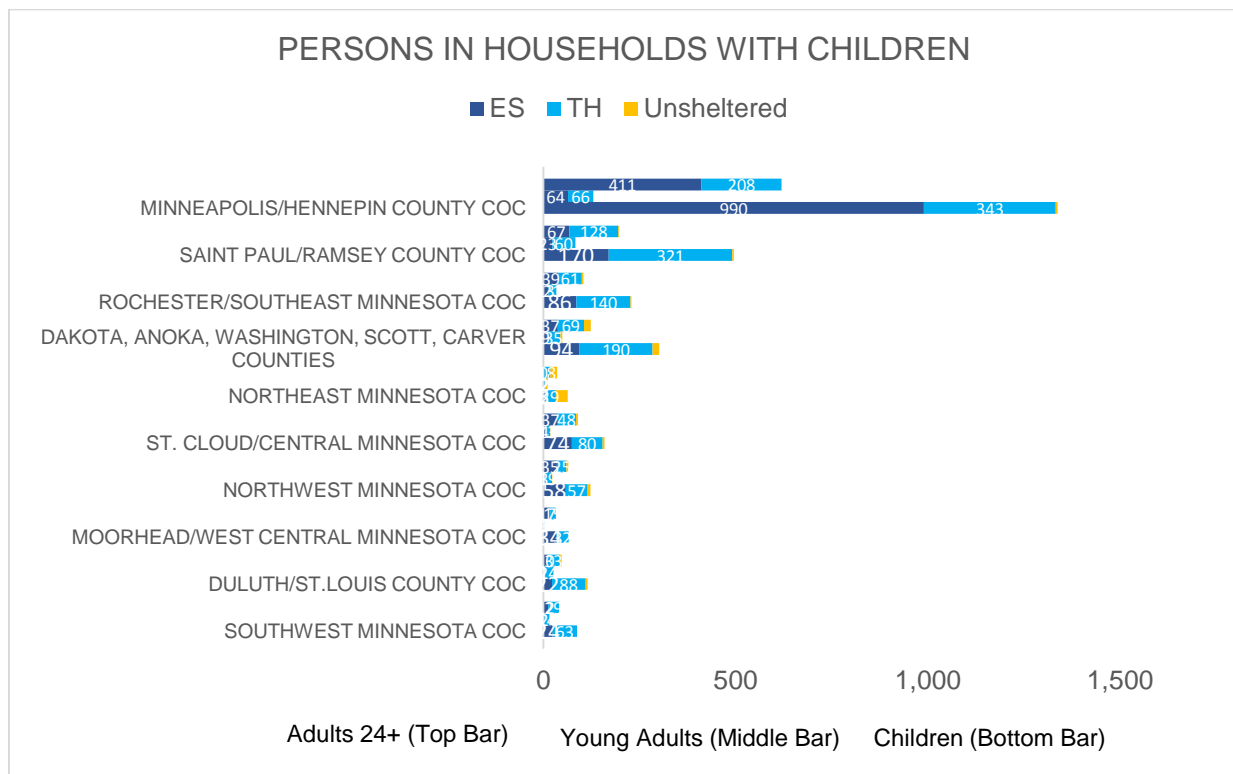
The additional beds are needed in 6 continuum of cares: Saint Paul/Ramsey County CoC (0 – 5 more beds needed), Dakota, Anoka, Washington, Scott, Carver Counties CoC (13 – 26 more beds needed), Northeast Minnesota CoC (36 – 39 more beds needed), St. Cloud/Central Minnesota CoC (20 – 46 more beds needed), Moorhead/West Central Minnesota CoC, (0 – 4 more beds needed), and Duluth/St. Louis County CoC (42 – 71 more beds needed).

Families With Children

Of the 4,725 homeless adults and children living together in families in Minnesota, 2,342 were in emergency shelters, 2,234 were in transitional housing, and 149 were without shelter. Eighty-four percent of the persons in households with children were living in five continuum of cares: Minneapolis/Hennepin County CoC (2,088 adults and children), Saint Paul/Ramsey County CoC (775 adults and children), Rochester/Southeast Minnesota CoC (367 adults and children), Dakota, Anoka, Washington, Scott, Carver Counties CoC (473 adults and children), and St. Cloud/Central Minnesota CoC (267 adults and children).



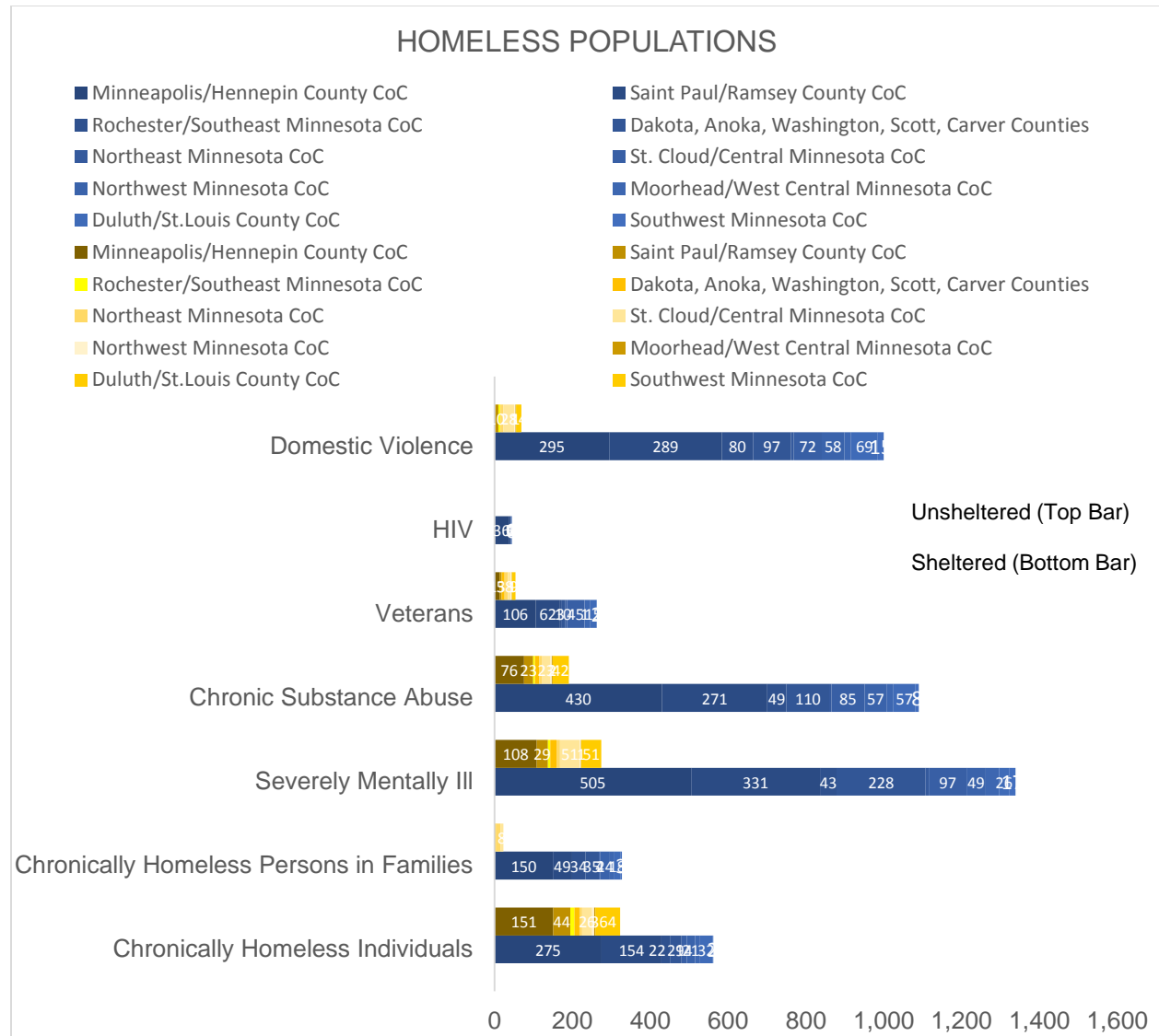
Although 149 adult and children were living together in families without shelter in Minnesota, the Housing Inventory Count reports 580 to 993 beds were available and not all of these beds may have been in available units. When evaluating the number of beds needed in each CoC, a total of 55 to 58 additional beds are needed for adults and children in families. Between 42 and 45 additional beds are needed in Northeast Minnesota CoC and 13 additional beds are needed in the Northwest Minnesota CoC.

Homeless Populations

In Minnesota, 14 percent of the 8,377 persons homeless on a given night in January 2014 were chronically homeless. Also, 19 percent were characterized as severely mentally ill and 15 percent were characterized as having chronic substance abuse. Veterans comprised 3 percent of the homeless population, domestic violence survivors comprised 12 percent of the homeless population, and persons with HIV/AIDS comprised 0.5 percent of the homeless population.



Chronically Homeless Persons

Of the 8,377 homeless people in Minnesota, 1,235 were chronically homeless. Twenty-eight percent of the chronically homeless persons were without shelter: 323 individuals and 23 persons in families.

Eighty-eight percent of the chronically homeless individuals without shelter were in the four CoCs: Minneapolis/Hennepin County CoC (151 individuals), Saint Paul/Ramsey County CoC (44 individuals), St. Cloud/Central Minnesota CoC (40 individuals), and Duluth/ St. Louis County CoC (96 individuals).

The Housing Inventory Count reports between 375 and 578 rapid rehousing, transitional housing, permanent housing, and safe haven beds were available for households without children. When evaluating the number of beds needed in each CoC, a total of 30 to 64 more transitional housing, permanent housing, and rapid-rehousing beds may be needed for chronically homeless individuals.

The beds are needed in five continuum of care areas: Rochester/Southeast Minnesota CoC (0 – 8 more beds needed), Northeast Minnesota CoC (3 – 4 more beds needed), St. Cloud/Central Minnesota CoC (0 – 8 more beds needed), Moorhead/West Central Minnesota CoC (0 – 3 more beds needed), and Duluth/St. Louis County CoC (27 – 41 more beds needed).

The chronically homeless persons in families without shelter were in three CoCs: Dakota, Anoka, Washington, Scott, Carver Counties (4 individuals), Northeast Minnesota CoC (11 individuals), and St. Cloud/Central Minnesota CoC (8 individuals). The Housing Inventory Count reports between 366 and 699 rapid rehousing, transitional housing, permanent housing, and safe haven beds were available for households with children. When evaluating the number of beds needed in each CoC, between 0 and 1 more transitional housing, permanent housing, and rapid-rehousing beds may be needed for chronically homeless persons in families. Depending on the number of beds in available units, more beds may be needed.

Domestic Violence Survivors

Of the 8,377 homeless people in Minnesota, 1,069 were escaping domestic violence. Six percent of the domestic violence survivors (69 individuals) were without shelter.

Three-fourths of the domestic violence survivors without shelter were in the Saint Paul/Ramsey County CoC, St. Cloud/Central Minnesota CoC, and Duluth/St. Louis County CoC.

The Housing Inventory Count reports between 17 and 64 domestic violence and rapid rehousing beds for households without children and between 108 and 177 domestic violence and rapid rehousing beds for households with children.

Depending on the number of beds in available units, between 1 and 17 more beds may be needed for adults and children escaping domestic violence in four CoC areas. With only 17 to 64 of the domestic violence beds available for adult individuals and no domestic violence beds available for adult individuals in three other CoC areas, additional domestic violence beds may be needed in three additional CoC areas. With no domestic violence beds available for households with children in one other CoC area, additional domestic violence beds may be needed in a seventh CoC area.

Conclusion

In Minnesota, there were 8,377 homeless persons and 795 persons without shelter. At least 5 additional beds are needed for children living alone without shelter, 77 to 92 additional beds are needed for young adults alone without shelter, 111 to 191 additional beds are needed for adult individuals without shelter, and 55 to 58 additional beds are needed for adults and children in families without shelter. At least 30 to 64 additional beds are needed for chronically homeless individuals, 0 to 1 additional beds are needed for chronically homeless persons in families, and 1 to 17 additional domestic violence beds are needed. Additional shelters or beds are needed in 7 to 8 of Minnesota's 10 CoCs.
