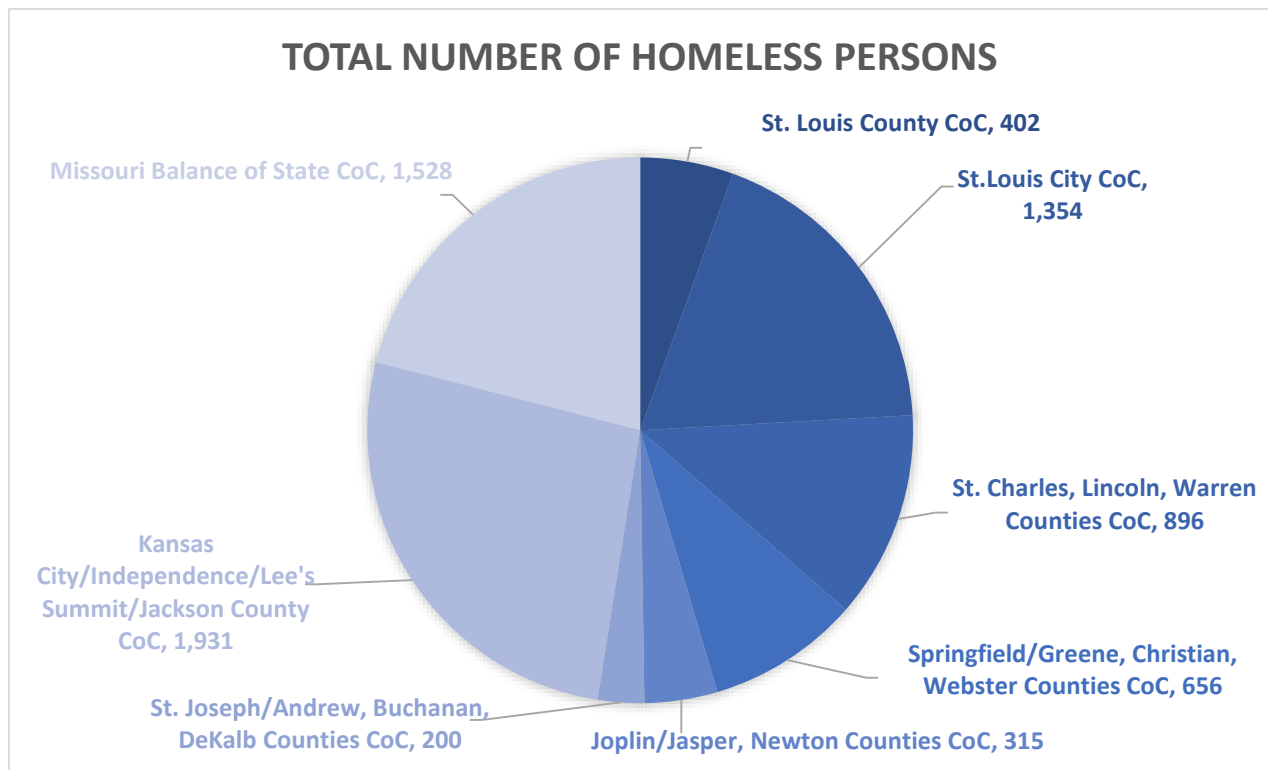


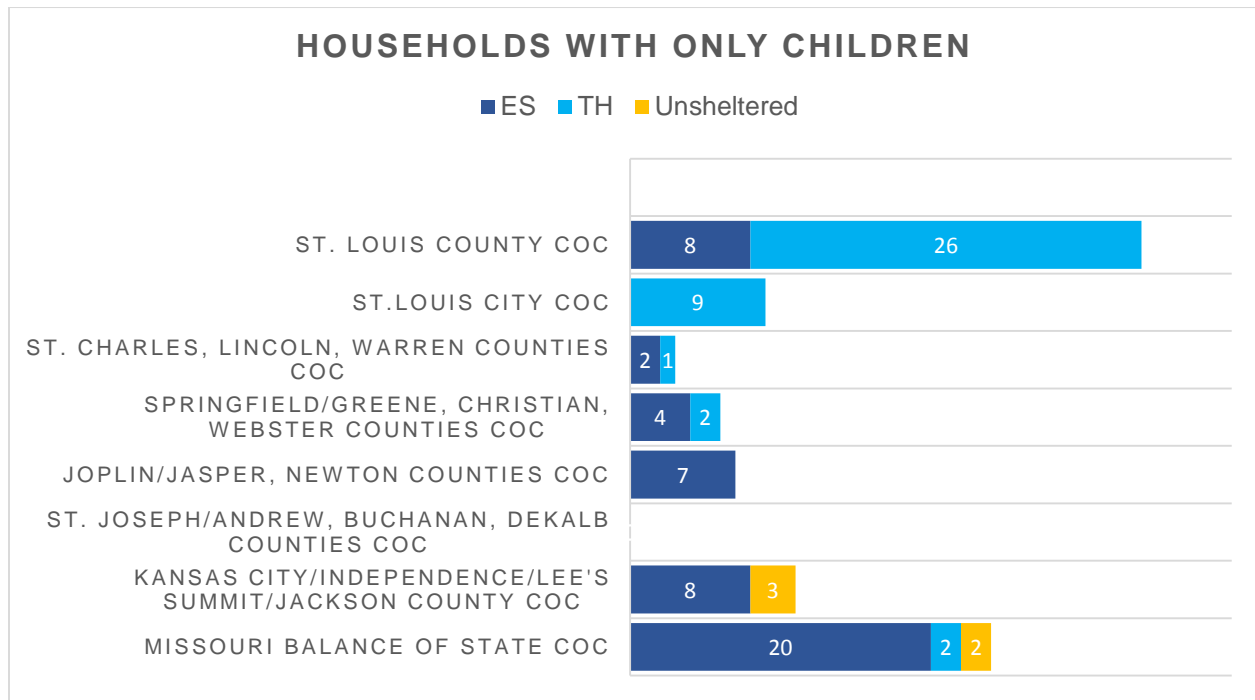
MISSOURI

In Missouri, there were 7,282 homeless persons on a given night in January 2014. As the figure shows, 1,931 of them were in the Kansas City/Independence/Lee's Summit/Jackson County CoC, 1,528 were in the Missouri Balance of State CoC, 1,354 were in the St. Louis City CoC, 896 were in the St. Charles, Lincoln, Warren Counties CoC, 656 were in the Springfield/Greene, Christian, Webster Counties CoC, 402 were in the St. Louis County CoC, 315 were in the Joplin/Jasper, Newton Counties CoC, and 200 were in the St. Joseph/Andrew, Buchanan, DeKalb Counties CoC. There were 94 children alone, 2,975 persons in households with children, 344 young adults ages 18 to 24 alone, and 3,869 adults ages 24 and older alone. Thirteen percent of the homeless persons in Missouri were without shelter.



Children Alone

Of the 94 children alone, 36 percent were in the St. Louis County CoC. In the St. Louis County CoC, 8 children were in emergency shelters and 26 children were in transitional housing. The 9 children in the St. Louis City CoC were in transitional housing. In the St. Charles, Lincoln, Warren Counties CoC, 2 children were in emergency shelters and 1 child was without shelter. In the Springfield/Greene, Christian, Webster Counties CoC, 4 children were in emergency shelters and 2 children were in transitional housing. The 7 children in the Joplin/Jasper, Newton Counties CoC were in emergency shelters. In the Kansas City/Independence/Lee's Summit/Jackson County CoC, 8 children were in emergency shelters and 3 children were without shelter. In the Missouri Balance of State CoC, 20 children were in emergency shelters, 2 children were in transitional housing, and 2 children were without shelter.



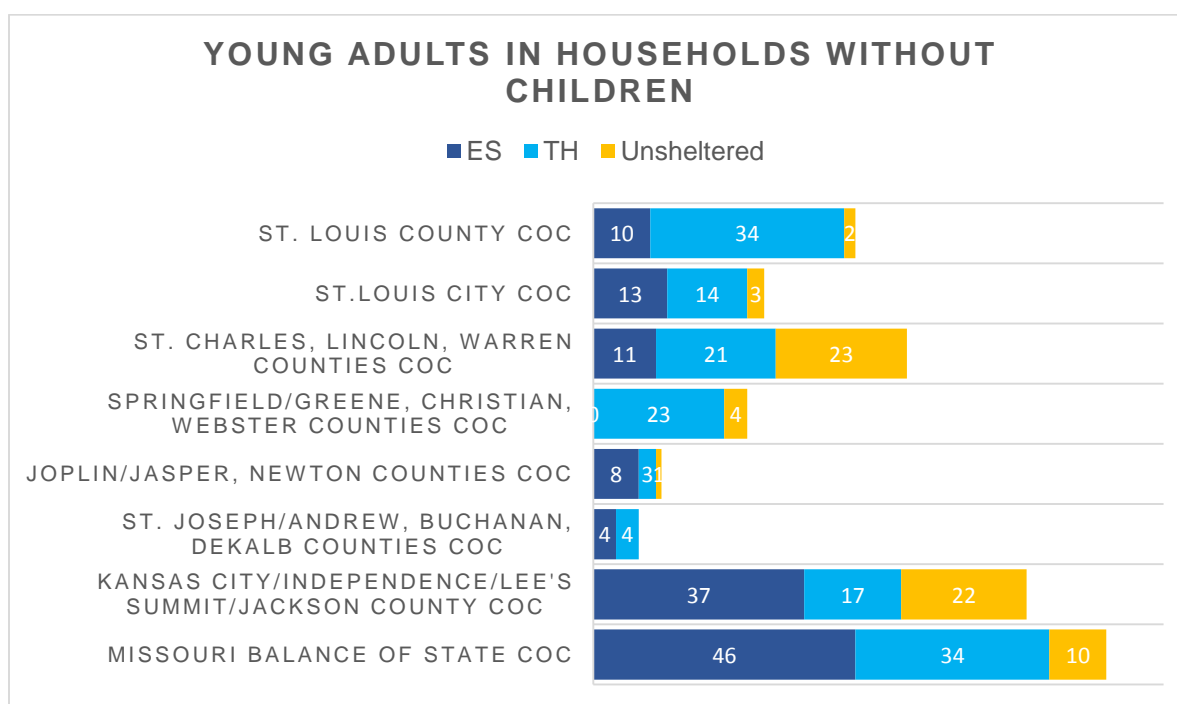
The Housing Inventory Count reports 97 to 127 youth beds available for children alone. When evaluating the number of beds needed in each CoC, a total of 2 additional beds are needed were for children living alone.

Young Adults Alone

Of the 344 young adults living alone in Missouri, 129 were in emergency shelters, 150 were in transitional housing, and 65 were without shelter. Twenty-six percent of the young adults were living in the Missouri Balance of State CoC, 22 percent were living in the Kansas City/Independence/Lee's Summit/Jackson County CoC, 15 percent were living in the St. Charles, Lincoln, Warren Counties CoC, 13 percent were living in the St. Louis County CoC, 8 percent were living in the St. Louis City CoC, 7 percent were living in the Springfield/Greene, Christian, Webster Counties CoC, 3 percent were living in the Joplin/Jasper, Newton Counties CoC, and 2 percent were living in the St. Joseph/Andrew, Buchanan, DeKalb Counties CoC.



Eighteen percent of the young adults were without shelter. Thirty-five percent of the young adults without shelter were in the St. Charles, Lincoln, Warren Counties CoC, 33 percent were in the Kansas City/Independence/Lee's Summit/Jackson County CoC, 15 percent were in the Missouri Balance of State CoC, 6 percent were in the Springfield/Greene, Christian, Webster Counties CoC, 4 percent were in the St. Louis City CoC, 3 percent were in the St. Louis County CoC, and 1 percent were in the Joplin/Jasper, Newton Counties CoC.

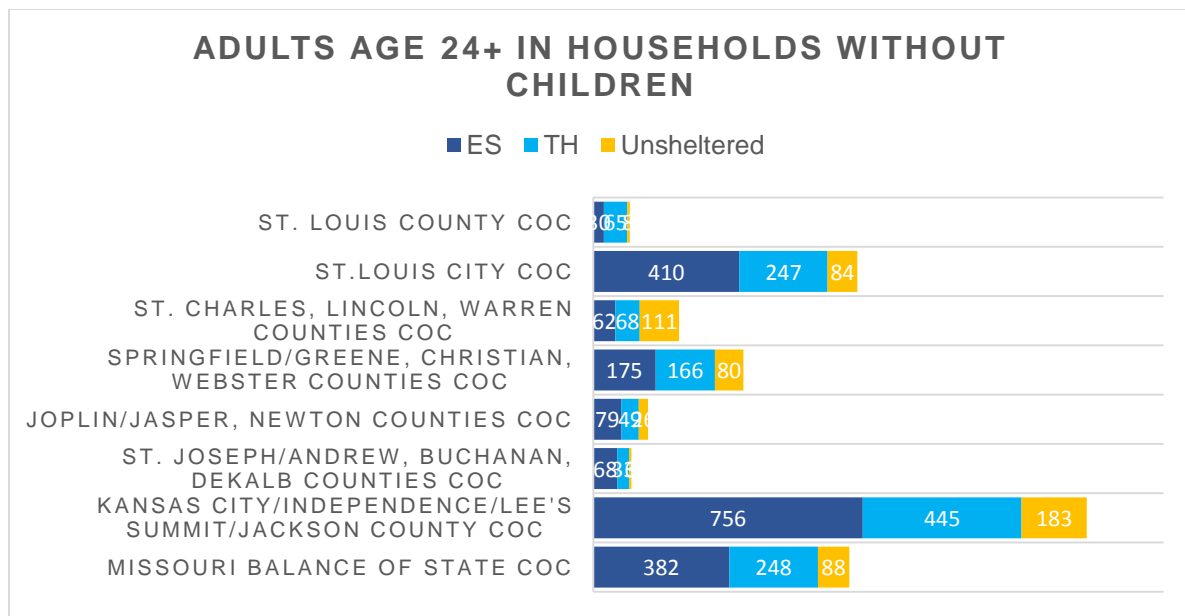
Although 65 young adults were without shelter in Missouri, the Housing Inventory Count reports only 2 to 32 youth beds were available for young adults alone. A total of 57 to 63 additional beds are needed for young adults alone without shelter in Missouri.

Adults Alone

Of the 3,869 adults age 24 and older living in households without children in Missouri, 1,962 were in emergency shelters, 1,321 were in transitional housing, and 586 were without shelter. Thirty-five percent of the adults age 24 and older were located in the Kansas City/Independence/Lee's Summit/Jackson County CoC, 19 percent were in the St. Louis City CoC, 18 percent were in the Missouri Balance of State CoC, 10 percent were in the Springfield/Green, Christian, Webster Counties CoC, 6 percent were in the St. Charles, Lincoln, Warren Counties CoC, 3 percent were in the Joplin/Jasper, Newton Counties CoC, and 2 percent were in the St. Louis County CoC and St. Joseph/Andrew, Buchanan, DeKalb Counties CoC.



Fifteen percent of the adult individuals were without shelter. Thirty-one percent of the adult individuals without shelter were in the Kansas City/Independence/Lee's Summit/Jackson County CoC, 18 percent were in the St. Charles, Lincoln, Warren Counties CoC, 15 percent were in the Missouri Balance of State CoC, 14 percent were in the St. Louis City CoC, 13 percent were in the Springfield/Greene, Christian, Webster Counties CoC, 4 percent were in the Joplin/Jasper, Newton Counties CoC, and 1 percent were in the St. Louis County CoC and St. Joseph/Andrew, Buchanan, DeKalb Counties CoC.

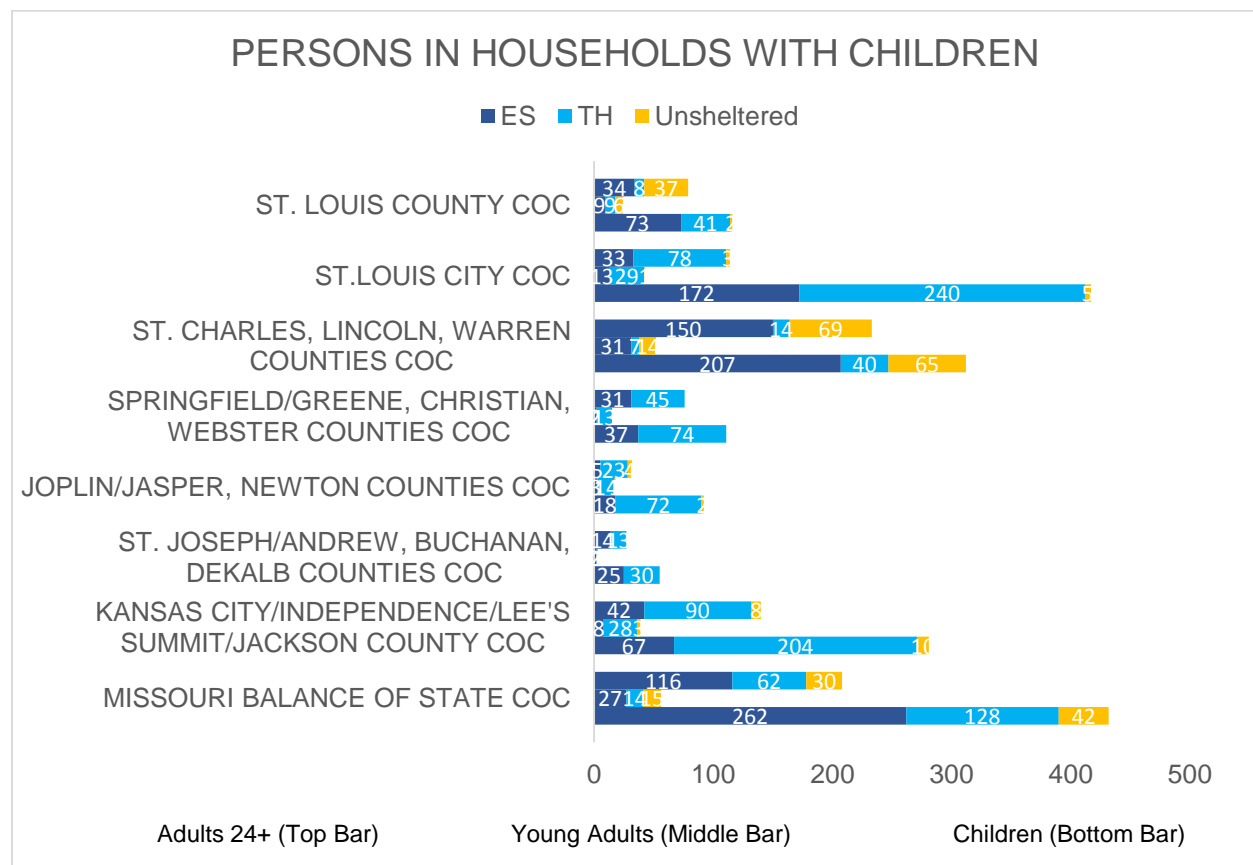
Although 586 adult individuals were without shelter in Missouri, the Housing Inventory Count reports only 628 to 1,209 beds were available for adult individuals age 24 and older. When evaluating the number of beds needed in each CoC, a total of 129 to 241 additional beds are needed for adult individuals without shelter. Thirty-seven additional beds are needed in the St. Louis City CoC, 60 to 91 additional beds are needed in the St. Charles, Lincoln, Warren Counties CoC, and 30 to 67 additional beds are needed in the Springfield/Greene, Christian, Webster Counties CoC.

Families With Children

Of the 2,975 homeless adults and children living together in families in Missouri, 1,381 were in emergency shelters, 1,277 were in transitional housing, and 317 were without shelter. Twenty-three percent of the persons in households with children were living in the Missouri Balance of State, 20 percent were living in the St. Charles, Lincoln, Warren Counties CoC, 19 percent were living in the St. Louis City CoC, 15 percent were living in the Kansas City/Independence/Lee's Summit/Jackson County CoC, 7 percent were living in the St. Louis County CoC, 6 percent were living in the Springfield/Greene, Christian, Webster Counties CoC, 4 percent were living in the Joplin/Jasper, Newton Counties CoC, and 2 percent were living in the St. Joseph/Andrew, Buchanan, DeKalb Counties CoC.



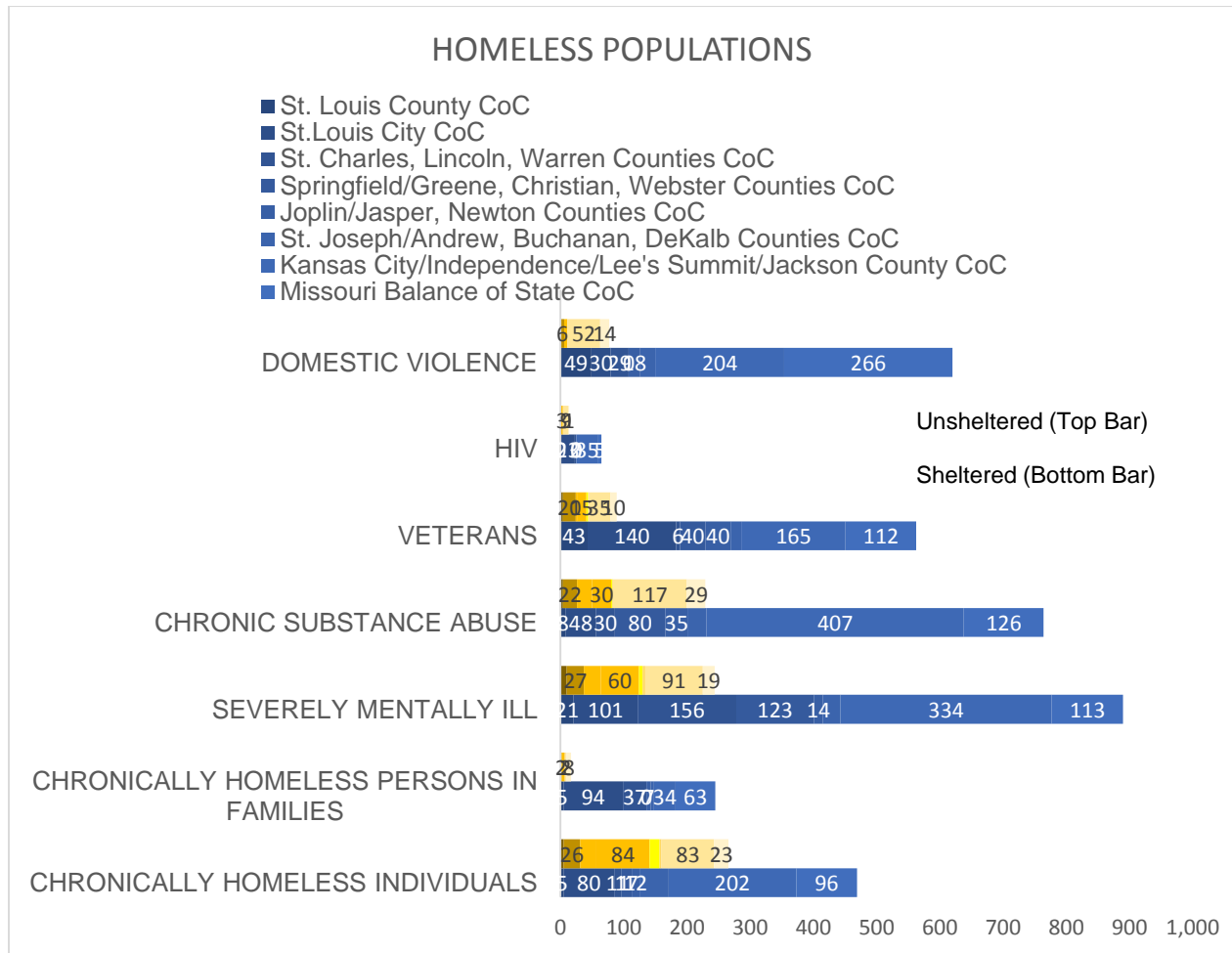
Although 317 adult and children were living together in families without shelter in Missouri, the Housing Inventory Count reports 787 to 1,390 beds were available and not all of these beds may have been in available units. When evaluating the number of beds needed in each CoC, a total of 63 to 106 additional beds are needed for adults and children in families. Between 3 and 15 additional beds are needed in St. Louis County CoC and 60 and 91 additional beds are needed in St. Charles, Lincoln, Warren Counties CoC.

Homeless Populations

In Missouri, 13 percent of the 7,282 persons homeless on a given night in January 2014 were chronically homeless. Also, 15 percent were characterized as severely mentally ill and 13 percent were characterized as having chronic substance abuse. Veterans comprised 8 percent of the homeless population, domestic violence survivors comprised 9 percent of the homeless population, and persons with HIV/AIDS comprised 1 percent of the homeless population.



Chronically Homeless Persons

Of the 7,282 homeless people in Missouri, 997 were chronically homeless. Twenty-eight percent of the chronically homeless persons were without shelter: 266 individuals and 17 persons in families.

Thirty-one percent of the chronically homeless individuals without shelter were in the Springfield/Greene, Christian, Webster Counties CoC, 31 percent were in the Kansas City/Independence/Lee's Summit/Jackson County CoC, about 9 percent were in each of St. Louis City CoC, St. Charles, Lincoln, Warren Counties CoC, and Missouri Balance of State CoC, and 6 percent were in the Joplin/Jasper, Newton Counties CoC.

The Housing Inventory Count reports between 317 and 448 rapid rehousing, transitional housing, permanent housing, and safe haven beds were available for households without children. When evaluating the number of beds needed in each CoC, a total of 83 to 98 more transitional housing, permanent housing, and rapid-rehousing beds may be needed for chronically homeless individuals. Between 72 and 75 addition beds are needed in Springfield/Greene, Christian, Webster Counties CoC, between 11 and 13 additional beds are needed in Joplin/Jasper, Newton Counties CoC, and between 0 and 10 additional beds are needed in St. Charles, Lincoln, Warren Counties CoC.

Forty-seven percent of the chronically homeless persons in families without shelter were in the Missouri Balance of State CoC, 29 percent were in the St. Charles, Lincoln, Warren Counties CoC, and 11 percent were in the St. Louis City CoC and Kansas City/Independence/Lee's Summit/Jackson County CoC. The Housing Inventory Count reports between 478 and 622 rapid rehousing, transitional housing, permanent housing, and safe haven beds were available for households with children. Therefore, there may have been enough transitional housing, permanent housing, and rapid-rehousing beds for chronically homeless persons in families.

Domestic Violence Survivors

Of the 7,282 homeless people in Missouri, 697 were escaping domestic violence. Eleven percent of the domestic violence survivors (77 individuals) were without shelter.

Sixty-seven percent of the domestic violence survivors without shelter were in the Kansas City/Independence/Lee's Summit/Jackson County CoC, 18 percent were in the Missouri Balance of State CoC, 7 percent were in the St. Louis City CoC, and 6 percent were in the St. Charles, Lincoln, Warren Counties CoC. The Housing Inventory Count reports between 180 and 461 domestic violence and rapid rehousing beds for households without children and between 275 and 541 domestic violence and rapid rehousing beds for households with children. Depending on the number of beds in available units, additional beds may be needed for adults and children escaping domestic violence in Missouri. With no domestic violence beds available for adult individuals in two continuum of care areas and little or no domestic violence beds available for adult individuals in four other continuum of care areas, additional domestic violence beds may be needed in six continuum of care areas.

Conclusion

In Missouri, there were 7,282 homeless persons and 973 persons without shelter. At least 2 additional beds for children living alone, 57 to 63 additional beds are needed for young adults alone without shelter, 129 to 241 additional beds are needed for adult individuals without shelter, and 63 to 106 additional beds are needed for adults and children in families without shelter. There may have been enough beds for chronically homeless persons in families, but at least 83 to 98 additional beds are needed for chronically homeless individuals and additional domestic violence beds may be needed. Additional shelters or beds are needed in 7 to 8 of Missouri's 8 CoCs.
